4. NEW BUSINESS:

- a. Resolve issue regarding Lake Marie Lodge Fishing Trip cancellation
 - Background: A trip to Lake Marie Lodge in Alaska was offered at the Caddis Festival in 2015 and 2016.
 Harold and Joan Skinner bid and paid \$3,500 to CPC in 2015 for the trip. Jim Impara and Barbara Plake
 bid and paid \$3,500 to CPC in 2016. The Skinners had scheduled their trip for July 1, 2016 but were
 notified a week before scheduled departure that Lake Marie Lodge had closed abruptly. Jim Impara and
 Barbara Plake had not scheduled a trip yet. The chapter paid Lake Marie Lodge \$3,500 for the 2015 trip
 but has not yet paid for the 2016 trip.

- A brief discussion was held, Bill Perrill motioned that CPC refund \$3,500 to both the Skinners and Plake/Impara. Bill Dvorak seconded the motion. The motion passed 7-0, with two abstentions (Impara & Plake).
- Keith Krebs noted that CPC needs to have a plan to pursue refund of the money we paid Lake Marie Lodge in 2015.

b. Fiber Festival Sponsorship

CPC received a request for a sponsorship of the upcoming Fiber Festival. A brief discussion was held. The
consensus was that this was not an event that fit our conservation focus, so CPC will not sponsor this
event.

5. OLD BUSINESS:

- a. BoD meetings attendance issue: Add BoD "Speed Meeting(s)?
 - · Discussion tabled for future discussion
- b. Banquet Games Manager(s) needed
 - Ann Klaiman currently manages the games at the Caddis Festival and is willing to continue in this capacity.
 The position requires State of Colorado Games Manager training, available on-line for \$20. Ann feels that
 it would be beneficial to have a more than one person available with the proper GM certificate. Ann is
 willing to coach someone through this training.
- c. Establish date for review of "Give Smart" fundraising system for 2017 Caddis Banquet August?
 - Give Smart fundraising system is an electronic bidding system similar to what was used at the CTU Spring Gala. It allows all bidding on auction items to take place electronically. Anyone wishing to bid on any auction items at the Caddis Festival would need to use a computer device. Devices can be rented for each event. It is a subscription service and training is required to implement. There would be a learning curve to overcome prior to the event, so a deadline is needed to decide whether or not we want to implement it for the 2017 Caddis Festival.
 - Discussion followed: Questions about whether this would be a benefit to the Festival and whether our attendees would embrace it or not. It would increase the time needed to get everything entered into the system, so donations would need to be in hand much sooner. No decisions made.
- d. Caddis Festival Chair(s) needed to replace Barbara
 - Barbara Plake is stepping down as Caddis Festival chair. Suggestions included Merna Kerss, Janet Franz and Andrea Schultz-Ward. Merna was assistant this past year and was paid about \$1,200. We might be able to get someone for around \$2,000. A previous candidate quoted a price of \$5,000.
 - Jim Impara motioned that CPC allocate up to \$5,000 to seek out a Caddis Festival Banquet Coordinator. Bill Dvorak seconded. The motion passed without dissent.
- e. CPC "Movie Night" Double Feature: Hank Patterson Film "The Mystery of the Cuttyrainbrown Trout" (1hr. 20min.)
 - Need to select one or two short films –30 min. Tom Palka has a short film on kayaking the Arkansas.
- f. Engaging with TU Veterans Service Partnership
 - Keith Krebs named VSP Coordinator
 - Keith Krebs on panel for discussion of Veterans Programs at CTU Rendezvous
 - Continuing with Project Healing Waters fly fishing outing(s)
 - Set up collaboration with Salida Veterans Expeditions (fishing outings; Badger Basin rehab with CMC-TU)
 - Poll CPC-TU membership to identifying Veterans
 - Bill Dvorak took a group of vets on a river trip last week.

 - Expanded the number of prizes from 6 to 9 based on feedback from last year. Two awards were made in the new category of "Most Interesting" one for two fish caught at once and one for best fishing outfit.
 - Special thanks to Mike and Carole Perry (food service), Bob Gray (measuring board construction), Stephanie Perko and Nancy Drennan (registration), Jerry Wright and Michael Harrington (cooks), and Dominique Naccarato with CPW for t-shirt distribution.
